Our behavioral inpatient care management is dedicated to individuals requiring hospitalization in an acute careor residential facility for the treatment of mental health or substance use conditions requiring 24-hour nursing care/supervision and an attending doctor. Levels of care include: inpatient psychiatric, acute detoxification and residential care.

We promote timely and efficient inpatient care to support the quickest recovery possible. And, our care managers work with the individual, their family, and the facility to coordinate services to help ensure safe and effective treatment and support upon discharge.

Note: Evernorth Behavioral Health complies with state and federal regulations, NCQA standards and current national medical criteria. Based on recent changes under the mental health parity federal regulation, partial hospitalization is now classified as an outpatient benefit and as a result, we do not offer precertification for partial hospitalization.

Levels of care

Inpatient Psychiatric – Represents the most intensive level of psychiatric care. Assessments and interventions are provided in a 24-hour secure and protected, medically staffed and psychiatrically supervised treatment environment. The goal is to stabilize individuals who typically pose a significant danger to self or others, or display severe psychosocial dysfunction, and return them to a level of functioning in which a lesser level of intense treatment can be provided.

Inpatient Acute Detoxification – Represents the most intensive level of substance use care. Provides 24-hour supervision, observation, and support for patients who are intoxicated or experiencing withdrawal. The primary goal is ensuring that the individual is stable, including the initiation and tapering of medications used for the treatment of substance use withdrawal, and then facilitating transferring to a setting in which a lesser level of intense treatment can be provided.

Inpatient Residential Care – Refers to treatment for substance abuse, mental illness or other behavioral problems delivered in a live-in health care facility such as a residential treatment center (RTC). Residential treatment is an intermediate-term approach to treatment that attempts to return the individual to the community.
